## Section 2. Hazard identification

**Classification of the substance or mixture** : CARCINOGENICITY - Category 2

This product contains TiO<sub>2</sub> which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. For many products, TiO<sub>2</sub> is utilized as a raw material in a liquid coating formulation. ### Methods and materials for containment and cleaning up

## Section 7. Handling and storage

### Precautions for safe handling
