Section 5. Fire-fighting measures

Extinguishing media

Specific hazards arising from the chemical : In a fire or if heated, a pressure increase will occur and the container may burst. Vapors may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back. This material is toxic to aquatic life with long lasting effects. Personal precautions, protective equipment and emergency procedures

Section 7. Handling and storage

Precautions for safe handling

Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.
