Lead exposure causes adverse developmental effects including brain damage in children and unborn fetuses. For many PPG products, TiO2 is utilized as a raw material in a liquid coating formulation. Most carbon blacks contain trace quantities of polyaromatic hydrocarbons (PAH). PAHs are not expected to be released in biological fluids and are therefore not likely available for biological activity. Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system.
