#### 4.1 Description of first aid measures

### 5.2 Special hazards arising from the substance or mixture

# 6.2 Environmental precautions

: Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air). Water polluting material. #### 6.3 Methods and material for containment and cleaning up

#### **Small spill**

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. #### 7.1 Precautions for safe handling

#### **Protective measures**
