### 4.1 Description of first aid measures

## SECTION 5: Firefighting measures

**Hazards from the substance or mixture** : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. ### 5.3 Advice for firefighters

### 7.1 Precautions for safe handling

#### Protective measures

: Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapour or mist. Use only with adequate ventilation. ## 8.2 Exposure controls

**Appropriate engineering controls** : Use only with adequate ventilation.
