### SECTION 6: Accidental release measures

### Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. The risk of cancer depends on the duration and level of exposure to dust from sanding surfaces or mist from spray applications.
