## 4. First aid measures

### Description of necessary first aid measures

### Methods and materials for containment and cleaning up

## 7. Handling and storage

Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Avoid release to the environment. ## 7. Handling and storage

Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers.
