The risk of cancer depends on the uration and level of exposure to dust from sanding surfaces or mist from spray opplications. Carbon black is utilized as a raw material in many liquid coating irmulations. In this case, the carbon black particles are bound in a matrix with no teaningful potential for human exposure to unbound particles of carbon black when the product is applied with a brush or roller. Sanding the coating surface or mist om spray applications may be harmful depending on the duration and level of exposure and require the use of appropriate personal protective equipment and/or ngineering controls (see Section 8). Most carbon blacks contain trace quantities of olyaromatic hydrocarbons (PAH).
