Based on the properties of the isocyanate components and considering toxicological data on similar mixtures, th mixture may cause acute irritation and/or sensitization of the respiratory system, leading to an asthmatic condition, wheezing and tightness of the chest. Repeate exposure may lead to permanent respiratory disability. Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit result in adverse health effects such as mucous membrane and respiratory system. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, loss of consciousness. Solvents may cause some of the above effects by absorption through the skin. There is some eviden that repeated exposure to organic solvent vapors in combination with constant lo noise can cause greater hearing loss than expected from exposure to noise alon splashed in the eyes, the liquid may cause irritation and reversible damage. Ingestion may cause nausea, diarrhea and vomiting.
