Precautions for safe handling

Protective measures

Based on the properties of the isocyanate components and considering toxicological data on similar mixtures, this mixture may cause acute irritation and/or sensitization of the respiratory system, leading to an asthmatic condition, wheezing and tightness of the chest. Repeated exposure may lead to permanent respiratory disability. For many products, TiO2 is utilized as a raw material in a liquid coating formulation.
