#### 5.3 Advice for firefighters

Special protective actions for fire-fighters

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. # **SECTION 7: Handling and storage**

#### 7.1 Precautions for safe handling

**Protective measures**
