# 6. Accidental release measures

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. ### Methods and materials for containment and cleaning up

### **Small spill**

# 7. Handling and storage

# **Precautions for safe** handling
