## 5.3 Advice for firefighters

**Special protective actions** for fire-fighters

: Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. ## 6.1 Personal precautions, protective equipment and emergency procedures

6.2 Environmental precautions

#### 8.2 Exposure controls

Appropriate engineering controls
