5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture : Mammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. 5.3 Advice for firefighters

Large spill

8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. The engineering controls also need to keep gas, vapour or dust concentrations below any lower explosive limits. Use explosion-proof ventilation equipment.

Individual protection measures
