# Section 7. Handling and storage

# **Precautions for safe handling**

**Protective measures** 

Put on appropriate personal protective equipment (see Section 8). Do not breathe vapour or mist. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid release to the environment.
