Description of necessary first aid measures

Specific hazards arising from the chemical : Combustible liquid. Runoff to sewer may create fire or explosion hazard. Methods and materials for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

Conditions for safe storage, including any incompatibilities : Store between the following temperatures: 0 to 35°C (32 to 95°F). Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Eliminate all ignition sources. Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use.
