Specific hazards arising from the chemical

Section 7. Handling and storage

Precautions for safe handling

Protective measures

• Put on appropriate personal protective equipment (see Section 8). Do not breathe vapour or mist. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid release to the environment.
