This product contains TiO2 which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. Section 7. Handling and storage

Special precautions

: Vapors may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back. Vapors are heavier than air and may spread along floors. Appropriate engineering controls

Use only with adequate ventilation.
