### 7.1 Precautions for safe handling

### **Protective measures**

Put on appropriate personal protective equipment (see Section 8). Avoid exposure obtain special instructions before use. Avoid exposure during pregnancy. #### 8.2 Exposure controls

Appropriate engineering controls
