Methods and materials for containment and cleaning up

Small spill

Special provisions

One possible (flammable) decontaminant comprises (by volume): water (45 parts), ethanol or isopropyl alcohol (50 parts) and concentrated (d: 0,880) ammonia solution (5 parts). Add the same decontaminant to the remnants and let stand for several days until no further reaction in an unsealed container. Other information

Prolonged or repeated contact may dry skin and cause irritation.
