Carbon black is utilized as a raw material in many liquid coating formulations. In this case, the carbon black particles are bound in a matrix with meaningful potential for human exposure to unbound particles of carbon black v the product is applied with a brush or roller. Sanding the coating surface or mist spray applications may be harmful depending on the duration and level of expose and require the use of appropriate personal protective equipment and/or engine controls (see Section 8). Most carbon blacks contain trace quantities of polyaror hydrocarbons (PAH). PAHs are not expected to be released in biological fluids a are therefore not likely available for biological activity. Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit result in adverse health effects such as mucous membrane and respiratory syster. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, loss of consciousness. Solvents may cause some of the above effects by absorption through the skin.
