#### 5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture : Mammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. #### Large spill

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations.
