Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Add the same decontaminant to the remnants and let stand for several days until no further reaction in an unsealed container. Section 7. Handling and storage

Precautions for safe handling
