## **SECTION 6: Accidental release measures**

#### **Small spill**

Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. #### Large spill

#### **Precautions for safe handling**
