# **6.2 Environmental precautions**

: Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air). Water polluting material. ## 6.3 Methods and material for containment and cleaning up

#### **Small spill**

#### 8.2 Exposure controls

Appropriate engineering controls
