#### **SECTION 4: First aid measures**

#### 4.1 Description of first aid measures

**Eye contact**: Check for and remove any contact lenses. Immediately flush eyes with running water for

#### 5.2 Special hazards arising from the substance or mixture

**Hazards from the** substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard.
