### **SECTION 4: First aid measures**

### 4.1 Description of first aid measures

**Eye contact**: Remove contact lenses, irrigate copiously with clean, fresh water, holding the eyelids

Hazards from the substance or mixture

# **6.2 Environmental precautions**

### **Special provisions**

: Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). One possible (flammable) decontaminant comprises (by volume): water (45 parts), ethanol or isopropyl alcohol (50 parts) and concentrated (d: 0,880) ammonia solution (5 parts). ### **Protective measures**
