# 6. Accidental release measures

**Environmental precautions**: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. ### Methods and materials for containment and cleaning up

# 8. Exposure controls/personal protection

### Appropriate engineering controls
