### 5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture : Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. ### Large spill

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. ### 8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation.
