# Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Appropriate engineering controls

: If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
