# SECTION 4: First aid measures

## 4.1 Description of first aid measures

Hazards from the substance or mixture : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. ## 7.1 Precautions for safe handling

#### **Protective measures**
