### Section 2. Hazards identification

This product contains TiO2 which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. ## **Section 5. Fire-fighting measures**

Specific hazards arising from the chemical

#### **Precautions for safe handling**

#### **Protective measures**
