# 6. Accidental release measures

#### Personal precautions, protective equipment and emergency procedures

### For non-emergency personnel

# **Precautions for safe** handling

# 7. Handling and storage

Conditions for safe storage: Store between the following temperatures: 0 to 35°C (32 to 95°F). Store in accordance with local regulations. Store in a segregated and approved area. # procedures
