## Delayed and immediate effects and also chronic effects from short and long term exposure

### **Conclusion/Summary**

: There are no data available on the mixture itself. Contains lead. Exposure to lead dust and fumes adversely affects blood and blood forming tissues, kidneys, liver, the central/peripheral nervous systems and male/female reproductive organs. Lead exposure causes adverse developmental effects including brain damage in children and unborn fetuses. For many products, TiO2 is utilized as a raw material in a liquid coating formulation. In this case, the TiO2 particles are bound in a matrix with no meaningful potential for human exposure to unbound particles of TiO2 when the product is applied with a brush or roller.
