5.3 Advice for firefighters

Special protective actions for fire-fighters

Small spill

Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. 7.1 Precautions for safe handling

Protective measures

Put on appropriate personal protective equipment (see Section 8). Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Avoid exposure - obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Do not get in eyes or on skin or clothing. Do not ingest. 8.2 Exposure controls

Appropriate engineering controls

: Use only with adequate ventilation. SECTION 8: Exposure controls/personal protection

Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary. Considering the parameters specified by the glove manufacturer, check during use that the gloves are still retaining their protective properties.
