Section 2. Hazards identification

Section 5. Fire-fighting measures

Specific hazards arising from the chemical

Precautions for safe handling

Protective measures

Conclusion/Summary

There are no data available on the mixture itself. Based on the properties of the isocyanate components and considering toxicological data on similar mixtures, this mixture may cause acute irritation and/or sensitization of the respiratory system, leading to an asthmatic condition, wheezing and tightness of the chest.
