# Section 7. Handling and storage

#### **Precautions for safe handling**

#### **Protective measures**

Put on appropriate personal protective equipment (see Section 8). Avoid exposure obtain special instructions before use. Avoid exposure during pregnancy. # Recommended monitoring procedures

: Reference should be made to appropriate monitoring standards. Reference to national guidance documents for methods for the determination of hazardous substances will also be required.

# Appropriate engineering controls
