## 6.1 Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

# **6.2 Environmental precautions**

**Small spill**

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilt product. ## **SECTION 8: Exposure controls/personal protection**

Appropriate engineering controls
