### 4.1 Description of first aid measures

### 5.2 Special hazards arising from the substance or mixture

### Large spill

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Appropriate engineering controls
