## Section 5. Fire-fighting measures

- Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. ## Section 7. Handling and storage

- A. Precautions for safe handling** : Put on appropriate personal protective equipment (see Section 8). If during normal use the material presents a respiratory hazard, use only with adequate ventilation or wear appropriate respirator.
