Section 4. First aid measures

Section 5. Fire-fighting measures

A. Extinguishing media

Suitable extinguishing media : Use an extinguishing agent suitable for the surrounding fire.

B. Specific hazards arising from the chemical : In a fire or if heated, a pressure increase will occur and the container may burst. This material is toxic to aquatic life with long lasting effects. C. Methods and materials for containment and cleaning up

Small spill : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Store in a corrosion resistant container with a resistant inner liner. Store locked up. Keep away from metals. Keep container tightly closed and sealed until ready for use.
