#### 6. Accidental release measures

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. ## 7. Handling and storage

#### **Precautions for safe** handling

### 8. Exposure controls/personal protection

# Appropriate engineering controls
