### 6. Accidental release measures

# 7. Handling and storage

Conditions for safe storage: Store between the following temperatures: 0 to 35°C (32 to 95°F). Store in accordance with local regulations. Store in a segregated and approved area. #### Other information

Prolonged or repeated contact may dry skin and cause irritation.
