Description of necessary first aid measures

Section 5. Fire-fighting measures

Extinguishing media

Suitable extinguishing media : Use dry chemical, CO₂, water spray (fog) or foam.

Specific hazards arising from the chemical : Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. Methods and materials for containment and cleaning up

Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Store locked up. Eliminate all ignition sources. Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use. Appropriate engineering controls : Use only with adequate ventilation. Conclusion/Summary : There are no data available on the mixture itself. Contains lead. Exposure to lead dust and fumes adversely affects blood and blood forming tissues, kidneys, liver, the central/peripheral nervous systems and male/female reproductive organs. Lead exposure causes adverse developmental effects including brain damage in children and unborn fetuses. Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, loss of consciousness. Solvents may cause some of the above effects by absorption through the skin.
