Extinguishing media

Suitable extinguishing media : Use dry chemical powder.

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Small spill : Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Vacuum or sweep up material and place in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor.

Large spill : Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Avoid creating dusty conditions and prevent wind dispersal. Dispose of via a licensed waste disposal contractor. Section 7. Handling and storage

- Precautions for safe handling** : Put on appropriate personal protective equipment (see Section 8). Avoid breathing dust. Wear appropriate respirator when ventilation is inadequate.
