### Methods and materials for containment and cleaning up

## Section 6. Accidental release measures

## Section 7. Handling and storage

- Precautions for safe handling** : Put on appropriate personal protective equipment (see Section 8). #### Other information :

Repeated exposure to high vapor concentrations may cause irritation of the respiratory system and permanent brain and nervous system damage.
