Section 7. Handling and storage

- Conditions for safe storage, including any incompatibilities** : Store between the following temperatures: 5 to 25°C (41 to 77°F). Store in accordance with local regulations. Store in a segregated and approved area. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. - Appropriate engineering controls** : Use only with adequate ventilation.
