Section 5. Fire-fighting measures

Section 6. Accidental release measures

- Environmental precautions : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. - Methods and materials for containment and cleaning up

Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Section 7. Handling and storage

- Precautions for safe handling : Put on appropriate personal protective equipment (see Section 8).
