The risk of cancer depends on the duration and level of exposure to dust from sanding surfaces or mist from spray applications. Most carbon blacks contain trace quantities of polyaromatic hydrocarbons (PAH). PAHs are not expected to be released in biological fluids and are therefore not likely available for biological activity.
