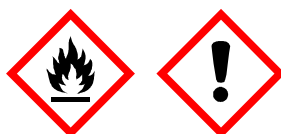

6.2 Environmental precautions : Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. 6.3 Methods and material for containment and cleaning up
